



# 79<sup>th</sup> Annual Glen Innes Hereford Bull Show & Sale

## Wednesday 24th July 2024

### Glen Innes Saleyards

The Show and Sale are on the **same day** with the Show commencing at 9.00 am and the Sale commencing at 2.00pm on WEDNESDAY 24<sup>TH</sup> JULY AEST at the Glen Innes Saleyards working in conjunction with the online platform via AUCTIONS PLUS.

**Elders staff try to see your entries as soon as they can prior to sale, HOWEVER if you are unsure about bringing an animal, we recommend that vendors give the Elders team a call to arrange an inspection. Carl Hooton, Elders Branch Manager Glen Innes (0417446017) or Lincoln McKinlay, Elders Stud Stock ( 0419239963) can arrange these inspections.**

#### MAXIMUM AGE LIMITS:

- Male Cattle:** Bulls must be U and T Bulls
- Stud Females** with the minimum age of 8 months and maximum age of 7 years as at 1<sup>st</sup> June. Calves at side of cow – calf to be no older than 9 months as at sale date.
- Commercial Females** must be Vendor bred, Hereford no more than 36 months old and they can have a calf at foot.

#### SALE APPLICATIONS/ENTRIES:

- Sale applications will be accepted at the discretion of the Committee and will only be accepted if the vendor acknowledges and agrees to the terms of the sale.
- No phone entries will be accepted, only emailed or faxed entry forms will be accepted.
- Stud Sale entry **CLOSING DATE 1<sup>st</sup> MAY 2024 close of business** – no late entries will be accepted.
- No limit on number of stud females that can be entered.
- Bull vendors can enter pens of commercial heifers, minimum 5 heifers per pen, maximum 10 per pen. They must be Vendor Bred, Hereford and no more than 36 months old and they can have calf at foot. The pen of heifers will be sold through the ring. These heifers will be assessed by Elders for Auctions Plus as per normal assessment rules for Auctions Plus. Commercial Females entry **CLOSING DATE 30<sup>th</sup> JUNE 2024** close of business (separate entry form attached).

All entries must include:

- The completed and signed entry form
- Sale notes (maximum of 25 words per lot)
- All entry fees, show entries and advertising costs to be paid by cheque or EFT Elders

#### SHOW SECTION:

- There are no restrictions this year due to the lower number of expected entries, i.e., a single bull can also be shown as part of pen of three.
- No more than two single bulls per class per vendor

## THE LAND FEATURE

The Committee no longer subsidize The Land Feature pages; however, we do encourage as many vendors as possible to be part of this. The committee will contact vendors prior to deadline to see who wishes to be part of The Land Feature.

## SALEYARD BEDDING:

- a) Vendors are required to supply their own straw or ask straw to be ordered in for them by contacting Elders Glen Innes

## ENTRY FEES:

- a) Must be completed via the entry form
- b) Entry fees will not be refunded for withdrawn lots after the closing date.

Entry fees will cover production of catalogue, sale listing on Auctions Plus, Herefords Australia website and Glen Innes Vendor Committee Facebook coverage along with Elders Glen Innes and Elders Stud Stock Facebook pages.

## RESERVES:

- a) Reserves will be set a minimum price. The sale organising committee encourage Vendors to set reasonable reserves, if outside the minimum to encourage buyers to bid on each animal.
- b) BULLS WHICH DO NOT RECEIVE THE MINIMUM PRICE IN THE SALE RING WILL COST PURCHASERS \$1000 ON TOP OF UPSET PRICE AFTER THE SALE**

## PHOTOS & VIDEOS:

- a) Elders and the committee strongly encourage all vendors to obtain high-resolution photos and videos. These must be submitted to Elders by **26 JUNE 2024**. This will enable proper advertising for our sale via the online catalogue, Facebook and newspapers. Ideally produced by a professional. Any vendors who need's assistance, please contact Elders.

## OUTSIDE AGENT REBATE:

And outside agent rebate of 2% is to be offered by all vendors and is to be deducted from proceeds. This will occur providing the outside agents nominate prospective purchasers in writing to Elders 24hrs prior to the sale. Settlement with selling agent must occur 7 days from the date of invoice.

## FREIGHT REBATE:

Freight rebate is offered to any individual purchaser who purchases 4 bulls or more, which will be pro-rated between all Vendors who sold.

## NLIS and SALE LOT NUMBER TAGS:

All exhibits must comply with the MLA requirements. All animals must be tagged with an NLIS accredited tag or device and provided Sale Lot Number Tag.

# CONDITIONS OF ENTRY

1. No animal shall be eligible for showing that has not been catalogued for sale with the agents conducting the sale, or for which entries have not been received by the prescribed closing date.
2. No animal shall be eligible for the Show and Sale that has not been correctly registered with the Society.
3. All Registered Animals whose nominations are accepted must:
  - a. Be identified to their pedigree by Herefords Australia
  - b. Pass Herefords Australia veterinary inspection covering – scrotal circumference, testicles, penis/prepuce, mobility, age, eyes & jaws and supply completed form
4. The vendor must be a financial member of the Society and shall warrant that he is the absolute owner of any animal entered by him or by his authority to the Saleyards and shall indemnify the Society against all claims on whatsoever ground and whatsoever cause made against the Society in respect of such animals at the insistence of any other person.
5. All animals must be legibly tattooed with the prescribed Society tattoo must have at least one legible tattoo inside one ear. If tattoos are illegible, the animal will fail inspection.
6. Minimum scrotal circumference: 18-21 months: 32cm, 21-24 months: 33cm, over 24 months: 34cm.
7. Entries are to be from herds that have Johnes minimum JBAS6 status.
8. DNA: whilst DNA testing is not compulsory it is highly recommended. We would also like to remind vendors that the correct description of Polled/Scurred be accurately recorded with Herefords Australia. Inspections will take place during scanning and any discrepancies will be noted on the Supplementary Sheet.
9. Entries are to include all updated vaccination records **INCLUDING** all dates. Pestivirus testing is to be carried out prior to nomination and no bull with a positive result will be accepted.
10. **All Bulls must be semen tested BY A VET or AI Technician who are employed by Accredited AI Centre (no longer needs to be done by a member of the ACVA) within 70 days prior to the sale.** \*\* Morphology useful but not compulsory.
11. Breedplan figures will be GROUP BREEDPLAN and accessed directly from the Society database.
12. **Vendors are required to supply copies of the following documents to the Elders office by Friday 19th July 2024 and upon arrival at the sale yards.**
  - Herd Health Status Declaration duly completed and signed by the appropriate persons as shown on the form
  - Bull Physical Report for each bull entered, completed, and signed by a registered veterinarian within 70 days prior to the date of sale
  - Semen Evaluation Report
  - Pestivirus test results
  - Copy of Public Liability Insurance
13. All bulls are to be weighed, fat scanned, and eye muscle scanned upon arrival at the saleyards. All bulls to be yarded by 11.00am Tuesday, 23rd July 2024.
14. Any bull that presents for inspection with 6 teeth **FULLY** erupted will be ineligible for show or sale
15. No substitution of a nomination can be accepted under any circumstances.
16. Sale Entry Fees Bulls - \$200 + \$20 GST so your entry fee will be \$220 per head. Sale Entry Fees Females - \$100 + \$10 GST so your entry fee will be \$110.00 per head Show Entry Fees – \$16.50 / entry (incl GST)
17. Vendors are to have 2 bulls per pen.
18. It will be the responsibility of the vendor to arrange his own fodder and straw for bedding requirements.
19. It is the vendor's responsibility to ensure their Public Liability Insurance covers these activities and provide a current copy of their Certificate of Currency at the time of entry. If policy expires prior to sale, then a new COC must be produced prior to sale and displayed on the pens at the sale. NB: ENTRIES WILL NOT BE ACCEPTED WITHOUT CURRENT CERTIFICATE OF CURRENCY.
20. No exhibit or person in charge thereof shall be equipped with, wear or display anything which indicates ownership of the exhibit whilst being judged.
21. All passed in bulls at the sale will be liable for Yard Dues as charged by the Glen Innes Severn Council.
